RESOLUTIONS PASSED BY TEMPLE BOARD AND VARIOUS SRILA PRABHUPADA DISCIPLES
ASSOCIATED WITH RADHA-GOVINDA MANDIR
August 21, 1985

- 1) The Lincoln Continental should be sold with the proceeds being used for a more modest car. Expected profit is to go to the BBT. (passed unanimously)
- 2) All foodstuffs given to Bhavananda Goswami should be offerable to and actually offered to Sri Sri Radha-Govinda. (passed unan.except for 1 abstention)
- 3) The "VIP" table should be removed and an open invitation be extended to all Srila Prabhupada disciples to take breakfast in one another's association. Location remains the same.
- 4) Bhavananda Goswami should change his servant immediately; ie, Bala should be assigned another service. A subcommittee can work out details, such as frequency of future changing of servants. Laksmi N. prabhu can explain this point to BG in more detail.
- 5) As already ruled by the GBC, all leaders, including BG should "religiously" attend all temple programs. (unan.)
- 6) This members of this body have observed that BG's classes have declined in philosophical content and at times are based solely on his own opinions, giving the false impression that his ideas represent the ISKCON line. It has also been observed that he has developed a tendency to make statements in his classes that are controversial, highly opinionated, insulting, and offensive to new guests, congregation and life members, as well as to the devotees attending. This tendency should be immediately corrected. (unan.)
- 7) Advaita Das should be appointed as "watchdog" over BG's disciples, reporting to Laksmi N.prabhu if and when any disciples fall into acute spiritual difficulty as a result of disturbance over their guru's problems. (unan.)
- 8) Someone from the Temple Board speak with Srila Ramesvara regarding BG and himself and discuss the respective roles of ISKCON and the initiating gurus. Srila Ramesvara's own sadhana should also be frankly discussed. This body gives Srila Ramesvara its vote of confidence, provided that he is prepared to exchange ideas concerning the preservation of the unity of ISKCON. (unan.)
- 9) This body agrees to continue with BG as GBC provided that he execute all these items of reform.
- 10) Before BG makes his presentation this evening devotees from this body discuss his plan with him in order to make sure that we can back up such presentation. (unan.)
- 11) When he is in NY, BG should involve himself more in temple preaching activities with increased Krsna conscious participation. There should be a sharp reduction of separate, secretive activity engaged in while wearing non-devotional garb.
